

**WAZO Z107.5
Z City Sendoff
Official Rules**

NO PURCHASE NECESSARY. OPEN TO PERMANENT LEGAL U.S. RESIDENTS WHO ARE AT LEAST 21 YEARS OF AGE RESIDING IN NEW HANOVER, PENDER, BRUNSWICK, AND COLUMBUS COUNTIES. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. ALL FEDERAL, STATE AND LOCAL REGULATIONS APPLY.

1. **HOW TO ENTER.** By entering, you agree to comply with all applicable laws and these Official Rules, and you agree to abide by all decisions of the Sponsors. The sweepstakes entry period begins on February 28, 2022 in the 6am hour and ends on March 11, 2022 in the 6pm hour. Only one (1) eligible entry may be made during the Promotion Period any additional entries received from any person will be voided.

There is one method of entry for a total of Forty (40) qualifiers.

How To Enter: Participants must listen for the Z City Sendoff sounder which will air up to four (4) times per day Monday through Friday between 6am and 6pm for a total of 10 weekdays. When you hear the cue to call be the 7th caller by calling (910)251-1075. Calls to any other number will not be accepted. There will be a total of Forty (40) qualifiers chosen by this method. Participants entering by phone will be charged standard phone rates for calls according to the terms and conditions in their calling plan. Wireless services are not available in all areas. This method runs from February 28, 2022 through March 11, 2022.

3. **ELIGIBILITY.** The sweepstakes is open only to permanent, legal U.S. residents 21 years of age as of February 28, 2022 who reside in North Carolina. All 40 Qualifiers regardless of party attendance registration will receive one (1) Z 107.5 toiletry bag upon pickup at the event or station during prize pick-up times.

Winner selection will take place on a designated date and time. Qualifiers will be notified of location by March 11, 2022 at 6 PM via phone call and/or e-mail. The Winner must contact Sun & Fun Media to book the trip within thirty (30) days after being contacted by the station on how to obtain their prize. Prize is non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winner is responsible for all taxes and fees associated with the receipt and/or use of the prize.
